- 4. NRSP-RC Update Mike Vayda/Dan Rossi
  - The committee met in Dallas, TX in June to discuss the current proposals and funding for all NRSP's
  - The committee discussed the purpose of NRSP's and the role of the NRSP-RC Committee.
  - Part of the NRSP-RC's charge is to identify new areas for possible NRSP's.
  - Five areas of research with significant support needs are:
    - o Germplasm
    - o Climate change
    - o Bioinformatics
    - o Development of standardized methodologies for life cycle analysis
    - Development of a common database to serve as a science foundation for functional foods research
  - It was suggested that NRSP Development Committees be proposed for these five areas.
  - The NRSP DC's would be created with a two year life.
  - Members of the NRSP-RC have agreed to prepare concept papers for these five proposed NRSP's
  - The overall proposal will be discussed at the July ESCOP meeting.
  - Reports on progress will be discussed during the August conference call and the proposals will be brought forward at the ESS meeting in September
